Oct. 4, 2016, PRIME meeting Battery Division business luncheon meeting

Meeting called to order at 12:45 PM by Robert Kostecki

Robert Kostecki (chair) called the meeting to order. This meeting is the 25<sup>th</sup> anniversary of the commercialization of the lithium-ion battery and a number of events were planned for the PRIME meeting. Largest ECS meeting ever, with almost 5000 in attendance. Directly after the luncheon meeting, ECS will record a podcast with several Battery Division members who played key roles in the research and development of LIBs.

Marca Doeff (secretary) presented minutes of the Phoenix (fall 2015) meeting. At that time, we were planning the 25<sup>th</sup> anniversary of the LIB celebration at the PRIME meeting, going on now. We are now more reliant on fundraising due to ECS's new financial model. The battery division wants to honor those who have contributed to the field. This includes named symposia (in honor of...), generally held in the fall. This fall there is a symposium in honor of Z. Ogumi. She also encouraged members to nominate fellows and candidates for the various awards. Minutes approved and seconded on the floor.

Shirley Meng (treasurer) presented the budget. Most expenses for student travel grants. She announced new award funding from MTI and Jiang family foundation, (\$25k over 5 years for postdoc awards) and K.M. Abraham for student travel grants. Two students were awarded travel grants by this mechanism this year. Budget was approved and seconded.

Robert thanked Shirley for her service and her role in soliciting this funding.

Chris Johnson (vice chair) presented planned symposia for spring and fall 2017. The student battery slam is a new symposium. Chris asks everyone to encourage students to send in abstracts. Please also send in suggestions for named symposia. Fall 2017 one will be in honor of Frank McLarnon.

Robert Kostecki announced winners of awards Student research award-B.D. Polat Karahan MTI postdoc awards-Yelena Gorlin and Liumin Suo Battery Technology award-Dominique Guyomard Battery Research award shared by Yang Shao-Horn and N. Imanishi Two new fellows this year-John Goodenough and Bor Yann Liaw.

Robert presented certificates of appreciation to symposium organizers present at the luncheon.

Robert Kostecki announced the new slate of Battery Division officers including a number of new members-at-large (Guoying Chen, Bryan McCloskey, Jie Xiao,

Prashant Kumta. Thomas Barrera). Several members-at-large are continuing on, including Boryann Liaw (ex-chair), Khalil Amine, Marina Yakovleva, Martin Winter, Dominique Guyomard, Minoru Inaba, John Muldoon, and Richard Jow. Chris Johnson will be chair, Marca Doeff will be vice-chair, Shirley Meng will be secretary, and Brett Lucht will be treasurer.

Robert discussed the revision to the Mission statement of the Battery Division, to be finalized at an ECS committee meeting later this week. This is a general effort to update and coordinate the missions of the divisions. Members who have any concerns should let know Robert know immediately.

Robert presented a list of JES focus issues since 2013. This provides revenue to the division. One planned for 2016 will be edited by Doron Aurbach and will focus on papers given at the 2016 IMLB meeting in Chicago. We are soliciting ideas for future focus issues.

1:30 meeting was adjourned. Directly after this meeting, Roque Calvo interviewed John Goodenough, Stan Whittingham, Zempachi Ogumi, Mike Thackeray, and Martin Winter about the birth of the lithium ion battery, for a podcast.
